# A MESSAGE FROM OUR LEADERS

#### It is an honor and privilege to bring you the 2024 Annual Report.

You already know us, but did you know that West Virginians for Affordable Health Care (WVAHC) is the only nonprofit organization in the state whose sole mission is to advance public policy-informed by the consumer voice-that connects more children and families to high quality, affordable healthcare?

After spending more than 10 years at Covenant House, it is an honor to work on emerging healthcare issues that so dramatically impact the lives of people in the state that I love so much.

WVAHC works to educate policymakers and the public about cost, quality and access to healthcare in West Virginia, including opportunities to expand health care access through public and private health insurance coverage, especially for children.

Below are just a few of our most recent successes of which WVAHC was a collaborative partner:

- Staunchly defended any reductions in Medicaid services and advocated for full funding
- Advanced the extension of Medicaid/CHIP enrollment for infants and children up to 12 months of age
- Supported the expansion of the Medicaid dental benefit from \$1,000 to \$2,000 over two years. It allows Medicaid recipients more flexibility to purchase dentures—both sets—at the same time
- Pushed back on Big Pharma when drug manufacturers started implementing restrictions on contract pharmacies under the federal 340 B program. WVAHC advocacy allows safety net providers to continue to provide discounted prescriptions
- Fought to protect robust immunization laws which ultimately resulted in Governor Justice vetoing anti-vaccination legislation passed by the Legislature
- Implemented caps of \$35 for insulin and the negotiation of drug prices for Medicare recipients
- Helped pass a bill to extend Medicaid coverage to pregnant women and their newborn infants to 185 percent of the federal poverty level and to provide coverage up to 1-year postpartum.

WVAHC's staff and board of directors are deeply grateful to our partners, supporters and funders, as well as all West Virginians who are joining us on the journey to bring a consumer voice to public policy so that every West Virginian has quality, affordable healthcare, and the opportunity to lead an informed, healthy, and productive life.



EMEE Voices: Elevating the Medicaid Enrollment Experience



Mariah Plante has been working on a year-long project uplifting the voices of West Virginians enrolled in Medicaid who have experiences with SUD recovery and/or parenthood.

In collaboration with Rhonda Rogombe at the West Virginia Center on Budget & Policy, Mariah has collected 20 video and audio responses from 10 counties, which will be used to help improve the Medicaid enrollment experience for families across the state.

# 2024 Social Media Highlights


During the month of **August**, WVHAC ran two social media campaigns. The first campaign was for National Immunization Awareness Month (NIAM). The second campaign was highlighting oral health in conjunction with the Oral Health and Equity Network (OPEN) to raise the profile of oral health.

Over the last 12 months, WVAHC has increased its social media reach on Facebook just over 435%



September was National Recovery Month, so WVAHC ran a month-long social media campaign around Substance Use Disorder (SUD) and Recovery. In addition to National Recovery Month, WVAHC also highlighted:

# 2024 ROCKEFELLER AWARD DINNER

WVAHC recognized Barbara Fleischauer with the distinguished Rockefeller Award earlier this year for her lifetime contributions to improving access to health care for West Virginians.



Barbara Fleischauer served in the WV House of Delegates for over 20 years where she sponsored and passed important legislation protecting the rights of women and children; expanding healthcare; advancing civil rights; and improving benefits for veterans and disabled Mountaineers.

The Rockefeller Award, named in honor of former West Virginia Senator Jay Rockefeller, is given annually to an individual for their work, dedication, and inspiring efforts to ensure that every West Virginian has access to affordable and quality healthcare coverage.





# Some of Fleischauer's most notable and enduring achievements include:

- Capping insulin costs for diabetics
- Improving access to medical care in rural West Virginia
- Increasing funding and insurance coverage for children with autism
- Creation of the Office of Oral Health.

## A COMMUNITY SUMMIT ON HEALTH CARE

WVAHC was thrilled to host its annual Medicaid Summit earlier this year, Medicaid Matters: A Community Summit on Healthcare

We have hosted the Medicaid Summit for over a decade to highlight the significance of the state's largest health insurance program and how it provides access to affordable care for the most vulnerable West Virginians.



#### **Session 2: Policy Talks**

The afternoon session consisted of policy conversations from local experts, Deputy Commissioner of the Bureau of Medical Services, Sarah Young; Jeremy Smith, WV Navigator; Gina Sharps, WV Oral Health Coalition; Rich Sutphin, WV Rural Health Association; and Leah Cook, Recovery Point. Approximately 50 people attended the Summit and 3 consumers received enrollment assistance.

In one of the poorest states in the country, the cost of health care in West Virginia weighs heavily on our residents. Medicaid is a lifeline.


# FINANCIAL STEWARDSHIP

### 2024 Revenue




